We have performed certain limited procedures with respect to cash basis financial information and compliance with certain state laws and accepted accounting practices for the City of Des Arc, Arkansas, as of and for the year ended December 31, 2023, and have issued our report thereon dated February 27, 2024. These procedures were not performed for the Water, Sewer and Gas Transmission and Distribution System Funds.
