Financial and Compliance Report

Town of Griffithville, Arkansas Officials and Council Members Legislative Joint Auditing Committee

A priority of Arkansas Legislative Audit is to assist local government officials by promoting sound financial management and accountability of government resources. The Legislative Auditor reports on the fiscal affairs of local governments, as well as compliance with relevant state laws and observance of good business practices to provide accountability for tax dollars expended to support government operations.

We have performed certain limited procedures with respect to cash basis financial information and compliance with certain state laws and accepted accounting practices for the Town of Griffithville, Arkansas, as of and for the years ended December 31, 2022 and 2021, and have issued our report thereon dated May 10, 2023. These procedures were not performed for the Water and Sewer Department. Management of the Town is responsible for maintaining the financial records and complying with state laws and accepted accounting practices.

The findings contained in this section relate to the following officials who held office during 2022 and 2021:

Mayor: Windle Porter Recorder/Treasurer: Amanda Benedict (appointed October 6, 2022) Brittany Gonzales (January 6, 2022 – September 30, 2022) Monaica Pettypool (January 1, 2021 – December 31, 2021)

We evaluated the Town's compliance with certain state laws concerning general and district court accounting, budgeting, purchasing, and investing and depositing of public funds.

Noncompliance with state law and accepted accounting practices was noted in the office of Mayor.

### <u>Mayor</u>

The budgets were not adopted by ordinance or resolution, in noncompliance with Ark. Code Ann. § 14-58-202.
