Financial and Compliance Report

Town of Menifee, Arkansas Officials and Council Members Legislative Joint Auditing Committee

A priority of Arkansas Legislative Audit is to assist local government officials by promoting sound financial management and accountability of government resources. The Legislative Auditor reports on the fiscal affairs of local governments, as well as compliance with relevant state laws and observance of good business practices to provide accountability for tax dollars expended to support government operations.

We have performed certain limited procedures with respect to cash basis financial information and compliance with certain state laws and accepted accounting practices for the Town of Menifee, Arkansas, as of and for the years ended December 31, 2023 and 2022, and have issued our report thereon dated September 20, 2024. These procedures were not performed for the Water and Sewer Department. Management of the Town is responsible for maintaining the financial records and complying with state laws and accepted accounting practices.

The findings contained in this section relate to the following officials who held office during 2023 and 2022:

Mayor: Terry Coleman (2023) Gary Green (2022) Recorder/Treasurer: Pamela Coleman District Court Clerk: Daron Goodrich (Hired June 1, 2023) Alyssa Gullett (Hired January 1, 2023, Resigned March 31, 2023) Donna Rappold (Resigned December 31, 2022) Police Chief: John Randall

We evaluated the Town's compliance with certain state laws concerning general and district court accounting, budgeting, purchasing, and investing and depositing of public funds.

Noncompliance with state law and accepted accounting practices was noted in the offices of the **Mayor** and the **District Court Clerk**.

District Court Clerk

The District Court Clerk was in noncompliance with Ark. Code Ann. § 16-10-209 and other proper accounting procedures as enumerated below.

- Cash receipts journal was not reconciled monthly to bank deposits.
- Monthly bank reconciliation was not prepared.
- Cash disbursements journal was not reconciled monthly to bank disbursements.
- Receipts were not deposited in a timely manner and bank deposit slips did not consistently indicate the range of
 receipts deposited.

A similar finding was issued in the previous two reports.

Mayor

An annual audit or agreed-upon procedures report and compilation was not submitted to Arkansas Legislative Audit for the Town's Water and Sewer Department for 2022 and 2021, as required by Ark. Code Ann. § 14-234-119.

This report is intended solely for the information and use of the Legislative Joint Auditing Committee, local Town government, state executive and oversight management, and other parties as required by Arkansas Code, and is not intended to be and should not be used by anyone other than these specified parties. However, pursuant to Ark. Code Ann. § 10-4-417, all reports presented to the Legislative Joint Auditing Committee are matters of public record and distribution is not limited.
