Cash

Findings: We found no exceptions as a result of the procedures.

Receipts

b. Agree ten customer payments on the accounts receivable subledger to deposit and billing documents.

c. For ten deposits, agree the cash/check composition of the deposit with receipt information.

 - b. Determine that five customer adjustments were properly authorized.
