INDEPENDENT ACCOUNTANT'S REPORT ON APPLYING AGREED-UPON PROCEDURES

We have performed the procedures enumerated below, which were agreed to by the management of the Town of Peach Orchard Water & Sewer Department, solely to assist you with respect to the accounting records of management as of and for the year ended December 31, 2022. The Town of Peach Orchard Water & Sewer Department management is responsible for the company's accounting records. This agreed-upon procedures engagement was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants. The sufficiency of these procedures is solely the responsibility of those parties specified in the report. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

Our procedures and findings are as follows:

Cash and Investments

- A. Perform a proof of cash for the year and reconcile year-end bank balances to book balance.
 - B. Determine the ending book balance is within 5% or \$500, whichever is greater, of the proof of cash.
 - C. Confirm with depository institutions the cash on deposit and investments.

We found no exceptions as a result of the above procedures.

Receipts

- 2. A. Determine total receipts per journal are within 5% or \$500, whichever is greater, of deposits per proof of cash
 - B. Agree ten (10) customer payments on the accounts receivable subledger to deposit and billing documents.
 - C. For one deposit, agree the cash/check composition of the deposit with receipt information.

We found no exceptions as a result of the above procedures.

Accounts Receivable

- A. Agree ten (10) customer billings to the accounts receivable subledger.
 - B. Determine that five (5) customer adjustments were properly authorized.

We found no exceptions as a result of the above procedures.

Disbursements

4. A. Determine total disbursements per journal are within 5% or \$500, whichever is greater, of deposits per proof of cash.

- B. Analyze all property, plant, and equipment disbursements.
- C. Determine all disbursements paid to employees other than payroll and ten (10) other disbursements were adequately documented. (Materiality level 5% of total dollars of selected disbursements or \$500, whichever is greater.)

We found no exceptions as a result of the above procedures.

Property, Plant, and Equipment

5. A. Determine that additions and disposals were properly accounted for in the records. (Materiality level - 5% of total equipment or \$500, whichever is greater.)

Long-Term Debt

- A. Schedule long-term debt and verify changes in all balances for the year.
 - B. Confirm loans, bonds, notes, and contracts payable with lender/trustee/contractor.
 - C. Determine that the appropriate debt service accounts have been established and maintained.

7. A. Determine that any items of financial significance were approved and documented in the minutes of the governing body's meetings.
